

## **SMARTMUSIC® SOFTWARE LICENSE AGREEMENT:**

**IMPORTANT-READ THIS AGREEMENT! BY INSTALLING THE SMARTMUSIC SOFTWARE, YOU AGREE TO BE BOUND BY THIS LICENSE AGREEMENT.** From time to time, MakeMusic, Inc. may change the terms in this Agreement. When the terms are changed, MakeMusic will post a notice online. The changes also will appear in this document, which you can access at any time through the [makemusic.com](http://makemusic.com) website in Terms & Conditions.

MAKEMUSIC, INC. ("MAKEMUSIC") is licensing the SMARTMUSIC SOFTWARE programs and/or mobile applications contained in this download or disk packet (collectively "the SOFTWARE") to you on the following terms and conditions:

### **PRIVACY INFORMATION**

Please review our Privacy Statement, which also governs your use of the SOFTWARE, to understand how we collect and use information about you. Our Privacy Statement is posted at [www.makemusic.com](http://www.makemusic.com).

### **GRANT OF LICENSE**

MAKEMUSIC grants you, as licensee, a nonexclusive right to use the SOFTWARE on a computer, mobile device and other compatible devices ("DEVICE") under the terms and limitations of this License Agreement and the Subscriber Agreement. To access most of the functionality of the SOFTWARE, you must subscribe to the SmartMusic electronic service by completing the subscriber registration process and agreeing to the Subscriber Agreement for SmartMusic, posted at [www.makemusic.com](http://www.makemusic.com). The Subscriber Agreement for SmartMusic limits your use of the SmartMusic software to one DEVICE at a time. Use of the SOFTWARE without a subscription is limited to use only of the samples that may be provided with the SOFTWARE by MAKEMUSIC.

For Educator Subscribers of the SOFTWARE, this license grants access to the SmartMusic Gradebook™ service for the above mentioned licensee. Only one individual educator is authorized to use the SmartMusic Gradebook service per purchased subscription license of the SOFTWARE. Educators responsible for grading individual students must obtain their own subscription license to the SOFTWARE. Classes that are taught by multiple educators can share access to the SmartMusic Gradebook service.

### **SOFTWARE UPDATES**

The SOFTWARE may automatically download and install updates from MAKEMUSIC. These updates are optional and on by default, and are designed to improve, enhance and further develop the SOFTWARE and may take the form of bug fixes, enhanced functions, new SOFTWARE modules, and completely new versions. You agree to receive such updates (and permit MAKEMUSIC to deliver these to you with or without your knowledge) unless you turn off update delivery.

### **OWNERSHIP**

As licensee, you own the printed documentation materials and the media on which the SOFTWARE is recorded, but MAKEMUSIC retains all ownership and rights in the SOFTWARE, including all rights in any portion(s) of the SOFTWARE present in any output of the SOFTWARE. ## **USE RESTRICTIONS**
